Language is a profound reflection of human culture and perception. Colour contains rich cultural, mythical, historical, religious, political, and linguistic connotations. The morpho-semantic analysis of color names in Igbo, a language spoken by the Igbo people of Nigeria, delves into the intricate relationship between linguistic morphology and the semantics of colors. This study aims to unravel the underlying structures and meanings associated with color terms in the Igbo language, exploring how these terms are constructed morphologically and the nuanced semantic distinctions they carry. In Igbo, color terms are often composed of morphemes that convey specific meanings. The study examines the morphological components of color names, dissecting the root words, prefixes, and suffixes that contribute to the overall meaning. Additionally, it investigates the semantic dimensions of these terms, exploring the cultural and contextual factors that influence the interpretation of colors in Igbo society. This research adopts a descriptive approach in the analysis of color terminology in Igbo language. It made use of the criteria outlined by Berlin and Kay (1969) in arriving at 'two-term basic colour system in the language. This research observed two basic colour terms which are 'ocha', oji/nji (white and black) while the rest are referred to as the non-basic colour terms in the language. The research methodology also involves a comprehensive analysis of Igbo color vocabulary, considering both basic color terms and more complex expressions. Linguistic corpora, native speaker interviews, and historical texts are employed to gather data for analysis. Through this rigorous linguistic investigation, the study uncovers the morphological patterns in the formation of color names, shedding light on the systematic processes underlying Igbo morphology. Furthermore, the research explores the cultural connotations and symbolism associated with different colors in Igbo culture. It delves into how specific colors are used in traditional rituals, ceremonies, and everyday life, reflecting the cultural significance and social meanings attached to these hues. By examining the semantic nuances of color terms, the study provides valuable insights into the cultural perceptions of colors in the Igbo community. The findings of this study have implications not only for linguistics but also for anthropology and cultural studies. Understanding the morpho-semantic aspects of color names in Igbo enriches our knowledge of both the language's structure and the cultural contexts in which it is embedded. Berlin & Kay (1969) pointed out that all languages contain two to eleven basic colours terms which includes: black, white, red, yellow, green, blue, brown, purple, pink, orange and gray. Conway, et.al (2016) suggest that differences in colour categorization between languages are caused by differences in the overall usefulness of colour to a culture or language group. Due to the differences in cultural connotations

of colour words, people from different cultural backgrounds have different feelings and understanding of the same colour words which leads to differences in colour symbolism from one nation to another. According to Minoru (2000), Colour symbolism, which exhibits an essential aspect of human cognition and imagination based upon it, plays an important role in religion, painting, poetry, literature, film, and many other fields, but has not been given due consideration in contemporary cognitive linguistics, which claims to be able to treat cultural and religious symbolism. As the influx of Igbo people around the world keeps increasing due to economic and educational purposes, there is a great need to analyze colour symbolism in Igbo language, since it is an indispensable part of its culture, tradition and lifestyle.

Theoretical Review

Here, we review the various theories that pertain to colour. According to Hardin C.L. (2013), The Berlin-Kay theory of basic colour terms maintains that the world's languages share all or part of common stock of colour concepts. Berlin & Kay (1969) advanced a Theory of Cross-cultural Colour Concepts centered on the notion of a basic colour term, which is a colour word that applies to a wide class of objects reliably used by most native speakers. Allan (2009), came up with the Connotations of Color Terms Theory which investigate the connotations of color terms with particular attention to figurative uses of black, white, brown, yellow, red, green, blue, and a few others.

Based on Allan, the connotations are judged on the basis of whether the phrases in which the color terms occur are typically orthophemistic, euphemistic, or dysphemistic.

Minoru (2000) in his book titled “A Cognitive Linguistic Study of Colour Symbolism” made a pioneering study of colour symbolism in that it is the first attempt to derive systematically the divergent meanings of colour terms as observed in such linguistic expressions. Minoru (2000) proposed a Symbolic Model Theory comprising initial meanings (IMs), derivation of symbolic senses, five principles of the study of colour symbolism and interrelationships between different symbolic meanings of a colour term. The Symbolic Model theory has been applied successfully to a large set of examples in six languages (English, French, German, Spanish, Chinese and Japanese), mode of data collected not only from various kinds of dictionaries and books but also from observation and native speakers of each language.

In Sun (2008) research on Sino-English Colour Words noted that, in cross-cultural communication, colour words, as a symbolic system, have different uses, cultural values and cultural connotations in



Chinese and English. This requires the language user to truly understand the cultural traditions, values, local conditions and customs of the country where the language is spoken, and study the meaning of color words, including many subtle and specific symbolic meanings, as well as the cultural information it carries, in order to effectively carry out cross-cultural verbal communication, and constantly promote and strengthen the cultural exchange and integration between people of various countries.

Morphological Structure of Igbo Color Names

The Igbo language employs a structured and systematic approach to construct colour names. Here, the colours are grouped into two basic colour terms which are 'Qcha' and 'Oji' (white and black) and other non-basic color terms in the language.

It is observed that the non-basic colour terms are expressed by referring to objects having the same color as the intended colour. It is also observed that colour terms can be used as copular verbs to express the colours observed in the language. The copular verbs; chaga/acha (white), ji (black) and agba (colour) complement the intended colors.

Some of these colour names are formed through reduplication and a combination of prefix(es), root words, and modifiers, allowing for precise descriptions of various shades of colours. Here's a breakdown of the key morphological elements used in Igbo colour names. Note that the prefixes are italicized and they only appear in the basic colour terms.

Prefixes

"Qcha": The prefix "Q" acts as a derivational morpheme and signifies the colour white. It is frequently used as the base for creating white-related colour terms. For example, "Qcha" means white, while "akwaqcha" refers to a white cloth.

"Oji-": The "O" prefix denotes the colour black. It's used to create words that describe various shades of black, such as "Oji" is black and "Oji unyi" means something or someone that's as black or dark as charcoal.

Root Words

Root words serve as the base for constructing color names. These are usually seen in non-basic colour terms. The non-basic colour terms are expressed by referring to objects having the same colour as the intended colour. For instance, "akwukwọndụ" is the root word for the colour green, while "odo" serves as the root for the colour yellow.

Modifiers

Modifiers are often added to colour terms to provide more specific descriptions. These modifiers can be adjectives, nouns, or other descriptive elements. For example:

"Qcha": This phrase modifies the base color "Qchasnoo" to describe pure white.

"Qchachuruechu": Here, "Qcha" is modified to describe off-white.

Adjectival Usage

Igbo colour terms can also be used as adjectives to describe objects or people. For example, "nwataọcha" and "nwokeoji" refers to a fair or light-skinned child and a dark complexioned man, illustrating how colour terms can extend beyond colours themselves to describe characteristics or identity.

Igbo colour terms are highly precise and allow for subtle distinctions between shades. For instance, while "Ọcha" represents white, various modifiers can be added to specify different shades of white.
